Enterprise M3 has received a notional allocation of £40 million for the period 2014-2020 from the European Structural and Investment Funds (ESIF) for use in the Enterprise M3 LEP area. One of the funding streams available is the European Regional Development Fund (ERDF) with £20 million to be allocated to projects in support of research and development, SME competitiveness, digital growth and low carbon initiatives. ERDF Calls are still open for bidding and the programme will continue to run beyond the Brexit date.
